I am honored to have been appointed to be Summit County Clerk of Courts. I am the first Black person to lead a countywide Charter Office and I could not be more thrilled to be here.

I received my Bachelor of Science in Psychology from Emory University in Atlanta. After Graduation, I became employed as a Delta Airlines flight attendant. My goal while at Delta was to unionize flight attendants like pilots, as I noticed that pilots were able to negotiate as a unit for fair and just workplace agreements. I worked full time as a flight attendant while attending the University of Akron School of Law. I graduated from the University of Akron School of Law in 1995, as a Dean's Club Scholar and was admitted to the practice of law.

I was previously a magistrate in the Summit County Court of Common Pleas and I have served the state in a legal capacity for over twenty five years. I was a magistrate in Summit County's domestic relations court and in the Summit County Juvenile court before I was appointed to the State Legislature.

As a former teamster and daughter of a UAW worker, my focus as a legislator was on the importance of rewarding hard work and putting family first. From the creation of new, better-paying jobs to fully funding schools and protecting children, I focused on using my legal expertise and work experience to address the biggest challenges facing the state and improve the quality of life for the residents of the 33rd House District.

As Clerk of Courts, I am committed to ensuring justice, transparency, and efficiency in our legal system and furthering the mission of the Summit County Clerk of Courts. I have received a wonderful and warm welcome from all the staff and I cannot wait to continue our journey as we work together.


Community Partnerships and Outreach

Kolkovich graduated from the University of Illinois with Bachelor of Science and Master of Science Degrees in Print Journalism in 2002 and 2003 respectively. After working as a freelance writer and then interning in the United States House of Representatives and the United States Senate, Kolkovich enrolled at the St. Louis University School of Law in the Fall of 2006 as a part-time student. While attending law school, he interned at the St. Louis Circuit Attorney's Office for a summer and worked part-time for a small personal injury law firm. After graduation in 2010, he moved to Ohio after his wife accepted a job with the Ohio State University. While waiting to take the bar, Kolkovich interned with the Summit County Prosecutor's Office in the Criminal Felony Division and for the Ohio Attorney General's Office in the Antitrust Division. Upon passing the bar, Kolkovich accepted a position in the Summit County Prosecutor's Office Juvenile Division, prosecuting abuse, neglect, and dependency cases. He moved to the Criminal Felony Division in February 2012. Kolkovich served as an Assistant United States Attorney for the Northern District of Ohio for eight months before returning to the Summit County Prosecutor's Office as the Community Outreach Prosecutor in May 2023.

Recent Updates from the County Executive
